Fri, Nov 20 Open arena and stalls available @6 PM. Fri Open riding is \$10 a horse. Sat, Nov 21st, ride times are 9 AM to 11aM. \$10 per 1/2 hour session. No ponying and barrels are set. Exhibitions are 11:30 to 2:30 PM \$5 each. Entries close for Sat at 2:30 PM. Run will start at 3 PM First Out Futurity Horses, Open, Youth, Exh for Poles, and Poles. Sun, Nov 22nd - Exhibitions are from 8 - 9:30 AM. Entries for Sun close at 9:30 AM. Sun Race will start at 10 AM - First Out Futurity Horses - Open - Youth - Awards & checks immediately following the race. Dress Code long sleeve/boots are required! We do have a photographer so if you choose a hat or anything on your head it must stay there or hat fines will apply (\$10 Hat fine payable to the Barrel Setters!). 80 % payback of entry fee's 100% of added money each day to the First Out Futurity and Open runs. Futurity Horses will need a copy of the papers before the race. Mail these in with your entry. SHOW IS OPEN TO EVERYONE MUST PRE ENTER FOR EARLY DRAW AND STALL PREFERENCES MAY ENTER ON SITE WITH NO LATE FEES NO REFUNDS AFTER DRAW IS DONE.
